Stage 2 Water Restrictions, Property Tax Due Date, Urban Food Garden Bylaw, Open Burning and Neighbourhood Emergency Preparedness Program

June 2011

#### Stage 2 Water Restrictions – June 15, 2011

Effective Wednesday, June 15, 2011, the District will be on Stage 2 water restrictions, as follows:

- Properties with an odd house number may water on Tuesdays & Saturdays within permitted hours.
- Properties with an even house number may water on Thursdays & Sundays within permitted hours.

Watering is restricted to a **maximum of 2 hours per designated day**. On your designated watering day you are permitted to water between the hours of **7:00 am - 9:00 am** or **7:00 pm - 9:00 pm**.

#### **REMINDER: PROPERTY TAXES**

Property taxes are due at the District Office by 4:00 pm on Monday, July 4, 2011.

#### **Urban Food Garden Bylaw**

At the Regular Council Meeting held Monday, May 9<sup>th</sup>, 2011, Council considered comments received from the public during the two workshops/open houses regarding the proposed Urban Food Garden Bylaw. Council has requested that staff prepare a further report incorporating Council's additional proposed amendments to the bylaw. Council also requested that staff prepare draft terms of reference for a potential committee that would contribute to the development of the

bylaw. Staff plan on bringing this report back to Council for its consideration at a Regular Council Meeting to be held in June.

#### Message from the Fire Chief - Open Burning

Residents should be aware that the fire season is upon us. Open burning, that is fire piles on the ground, is now closed until October 15<sup>th</sup>. Incinerators are still permitted at this time but could be closed any time conditions dictate. Incinerators have a few rules applied (for a copy of the complete Bylaw No. 86, please go to the District website at www.lantzville.ca) and they also require a free permit available at the District Office. Recently your Fire Department has been out to address some smoke and ash issues in the "Winds" areas and residents should be aware of a few basic rules. The two most frequently overlooked are those of wind speed and venting. Burning is not permitted when wind speed exceeds 15 kph. This is anything much more than a gentle breeze. The venting index is a guide generally applied to burning on a larger scale but residents should be cognizant of smoke's ability, or not, to escape. This is a gauge of how well the smoke you produce will rise and not seriously affect your home and others. Rainy days are seldom good days to burn. A guide may be found on the Ministry of Environment website. Incinerators must be screened with a mesh no greater than approximately 1 inch mesh and should always be burned as hot as possible. This helps to reduce smoke and ash.

Remember, when you burn, if you would find the smoke or the ash fallout offensive at your place, chances are your neighbour would too.
