Fireworks

With Halloween just around the corner, the District would like to remind residents that a permit is required for any fireworks displays within District boundaries. However, the District does not recommend family fireworks or informal neighbourhood displays.



The use of fireworks dramatically increases the risk of fire and injury. Each year thousands of people, most often children and teens, are injured while using fireworks. If you are approved for a permit it is important to let your neighbours know when and where you will be discharging the fireworks so that they can make arrangements for their pets

Stage 2 Water Restrictions Still in Effect

Restrictions are as follows:

Odd house numbers watering days are Tuesdays and Saturdays within permitted hours.

Even house numbers watering days are Thursdays & Sundays within permitted hours.

Watering is restricted to a maximum of **2 hours** per designated day between the hours of 7:00 - 9:00 am **OR** 7:00 - 9:00 pm.

Please note that watering restrictions only apply to those property owners who are on the District's community water system. However, we also encourage those with private wells to exercise water conservation.

2014-2018 Five Year Financial Plan
