

**DISTRICT OF LANTZVILLE
BYLAW NO. 66.1, 2009**

**A BYLAW TO AMEND
"DISTRICT OF LANTZVILLE SEWER RATES & REGULATIONS BYLAW NO. 66, 2007"**

The Council of the District of Lantzville in open meeting assembled, enacts as follows:

- A. "District of Lantzville Sewer Rates and Regulations Bylaw No. 66, 2007, is hereby amended as follows:
- 1.0 INTERPRETATION - Part 2 Definitions Section 2.1** is hereby amended by deleting the definition for "Local Area Service" and replacing it with the following definition immediately following the definition for "District" as follows:
- "Local Area Service"** means those properties within the boundaries established by "District of Lantzville Sanitary Sewer Collection System – Phase I Local Area Service Bylaw No. 47, 2007"; and "District of Lantzville Sanitary Sewer Collection System – Phase 2 Local Area Service Bylaw No. 75, 2009" as well as subsequent amendments.
- 2.0 SERVICE CONNECTIONS – Part 3 Individual Connection Section 3.1** is hereby amended by adding the following terminology immediately following "District of Lantzville Sanitary Sewer Collection System – Phase I Local Area Service Bylaw No. 47, 2007" as identified in Schedule 'A' as follows:
- and "District of Lantzville Sanitary Sewer Collection System – Phase 2 Local Area Service Bylaw No. 75, 2009" as identified in Schedule 'A1'*
- 3.0 SERVICE CONNECTIONS – Part 3 Individual Connection Section 3.2** is hereby amended by adding the following terminology immediately following "District of Lantzville Sanitary Sewer Collection System – Phase I Local Area Service Bylaw No. 47, 2007" as identified in Schedule 'A' as follows:
- and "District of Lantzville Sanitary Sewer Collection System – Phase 2 Local Area Service Bylaw No. 75, 2009" as identified in Schedule 'A1'*
- B. Adding **Schedule 'A1'**, immediately following Schedule 'A', attached to and forming part of this Amendment Bylaw.
- C. **Schedule 'B' of "District of Lantzville Sewer Rates and Regulations Bylaw No. 66, 2007"** is hereby amended as follows:
- 4.0** By deleting Schedule 'B' as adopted, and replacing the Schedule with Schedule 'B', attached to and forming part of this Amendment Bylaw.

This bylaw may be cited as the "District of Lantzville Sewer Rates and Regulations Bylaw No. 66, 2007, Amendment Bylaw No. 66.1, 2009".

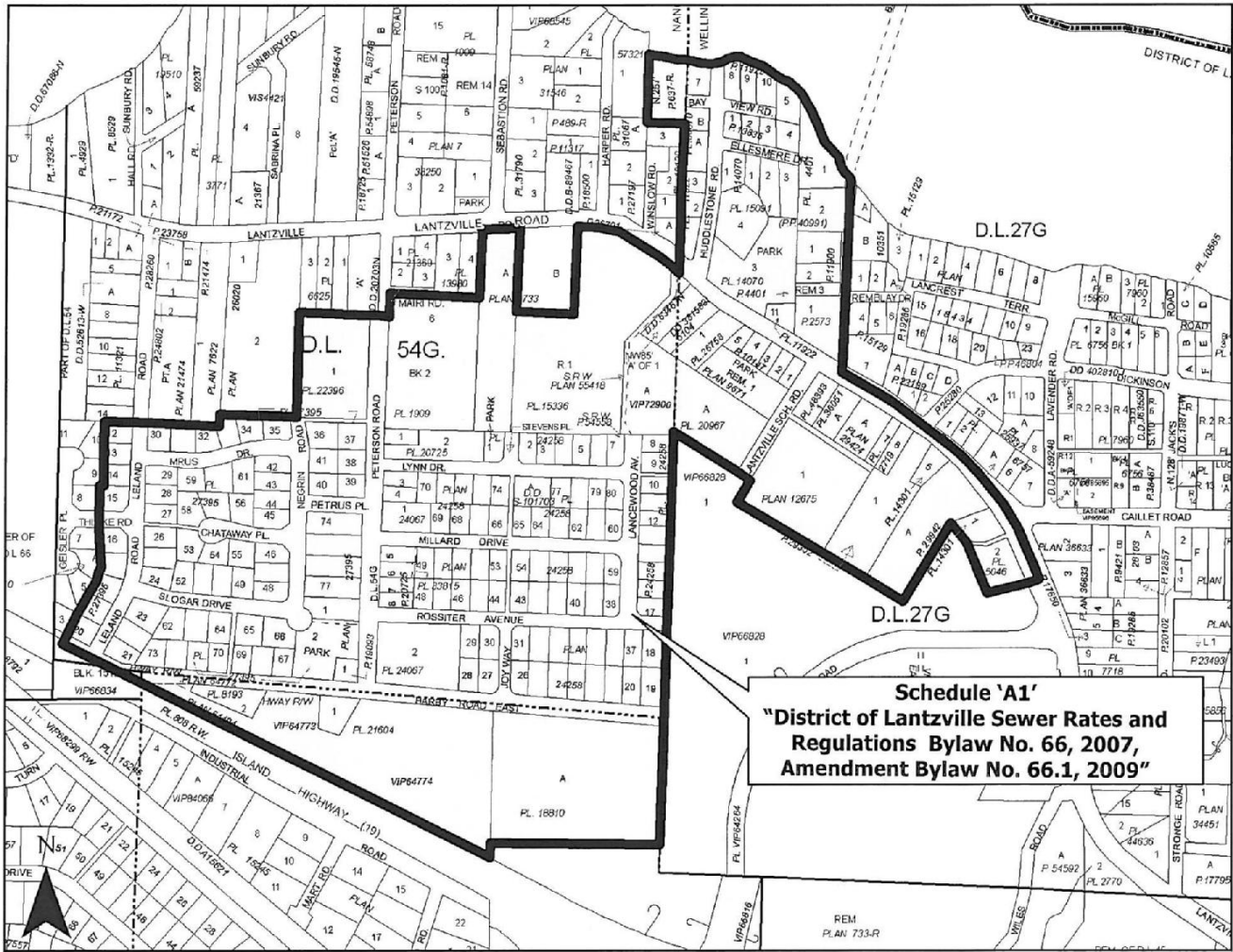

SCHEDULE 'B'
[Section 18.1]
SERVICE CONNECTION FEE

In addition to any fees for a Building Permit application the following Service Connection fee to defray the cost of laying a Sewer Connection shall be paid in accordance with section 18.1 of the Bylaw:

- (a) Connection Fee \$1,500.00

NOTES:

These connection fees are for work within the road right-of-way. Further costs to physically connect the public sewer from the property line to a building are at the expense of the property owner.

- (b) The Connection Fee in (a) above is reduced to \$500 for any Building Sewers completed under this bylaw and approved by the District up to June 30th, 2010.
- (c) The Connection Fee in (a) above is reduced to \$500 for any building sewers completed under this bylaw for those property owners subject to a pump purchase, and approved by the District up to December 31st, 2010.
