

**DISTRICT OF LANTZVILLE  
BYLAW NO. 64, 2007**

**A bylaw to authorize the expenditure of money from the General Renewal Machinery and  
Equipment Reserve Fund**

---

**WHEREAS** the District of Lantzville Council has established a General Renewal Machinery and Equipment Reserve Fund for purchasing , upgrading, replacement or renewal of assets;

**AND WHEREAS** section 189 of the *Community Charter* states that money in a reserve fund, and interest earned on it, must be used only for the purpose for which the fund was established;

**AND WHEREAS** there is an accumulated balance in the District of Lantzville General Renewal Machinery and Equipment Replacement Reserve Fund of four hundred thirty eight thousand and sixty six dollars and eighty four cents (\$438,066.84) as at August 31, 2007, which has been calculated as follows:

Balance in Fund as at December 31, 2006	\$428,075.91
Add: interest earnings year to date	9,990.93
 Balance in Fund as at August 31, 2007	 <b><u>\$438,066.84</u></b>

and within this balance there are funds of \$49,700.00 currently available that are earmarked for the purchase of equipment. 5 Head Sets (\$5,500.00), 5 Pagers (\$3,600.00) and Jaws of Life (\$40,600).

**NOW THEREFORE** the Municipal Council of the District of Lantzville in open meeting assembled hereby enacts as follows:

That the sum of forty nine thousand and seven hundred dollars (\$49,700) is hereby appropriated from the District of Lantzville General Renewal Machinery and Equipment Reserve Fund to be expended for the purchase of 5 Head Sets, 5 Pagers and Jaws of Life.

Should any of the above amount remain unexpended after the expenditures hereby authorized have been made, any unexpended balance shall be returned to the credit of the District of Lantzville General Renewal Machinery and Equipment Reserve Fund.

This bylaw may be cited for all purposes as “District of Lantzville General Renewal Machinery and Equipment Reserve Fund Expenditure Bylaw No. 64, 2007”.

**READ A SECOND TIME** this 9<sup>th</sup> day of October, 2007.

**READ A THIRD TIME** this 9<sup>th</sup> day of October, 2007.
