PURPOSE

To consider an application to construct a new dwelling within the DPA I - Watercourse Protection and DPA IV- Coastal Protection Development Permit Area pursuant to the "District of Lantzville Official Community Plan Bylaw No. 50, 2005", and to grant variances for:

- i. The proposed building height from 8 m to 9.8m and
- ii. The watercourse setback from 15m to 10m.

BACKGROUND

The subject property (shown on Attachment 1), zoned Residential 1 (RS1) pursuant to the "District of Lantzville Zoning Bylaw No. 60, 2005", is located at 7144 Eby Road and legally described as Lot 1, District Lot 53, Nanoose District, Plan 22717. The intent of this application is to construct a new dwelling and attached garage on the property (see Attachments No. 2 and 3).

The property is a relatively flat, low elevation property bounded by Nanoose Bay to the north, Eby Road to the west, Shangri-La Road to the south and residential homes to the east. The lower third (to the south) of the property is bisected by Knarston Creek. The existing residential structures and other accessory use buildings will be demolished with the exception of an existing garage which is to be retained with only renovations contemplated.

There are two development permit areas (DPA) applicable to this property, DPA I – Watercourse Protection and DPA IV – Coastal Protection pursuant to "District of Lantzville Official Community Plan Bylaw No. 50, 2005".

DPA I – Watercourse Protection designation is intended to minimize the impact of the built environment on fish habitat and fish supportive watercourses, as well as to minimize the effect of seasonal flooding on the built environment.

DPA IV – Coastal Protection designation is intended to ensure that potentially hazardous conditions are avoided and that the integrity of the slopes and shorelines are maintained. The area covered by this designation extends a distance of 15m inland from the natural boundary of the property.

DISCUSSION

Watercourse Protection:

The owners have retained Aquaparian Environmental to complete Riparian Areas Regulation (RAR) assessment. The RAR assessment is required for the proposed redevelopment of the parcel to determine the buildable area, protective stream setbacks and mitigation/restoration measures for the riparian area.

The RAR assessment recommends a 10m streamside Protection and Enhancement Area (SPEA) on both sides of Knarston Creek. The SPEA is considered a no-build area and is considered as sensitive habitat to support fish and fish habitat. That said, a portion of the existing garage (which is grandfathered) is located within the 10m SPEA on the south side of the creek and will be renovated.

Aquaparian is recommending intensive riparian restoration of approximately half of the SPEA to compensate for the setback reduction (see Attachment No. 4). The result will double the existing vegetation zone adjacent to the creek and replace invasive species with native plants resulting in an improvement over the existing conditions. The development permit shall include the

recommendations outlined the Vegetation Management Plan, Installation Recommendations, and Environmental Protection Plan as stated in the report prepared by Aquaparian Environmental Consulting Ltd. dated May 19,2016 and titled "Environmental Services – Development Permit Area Riparian Restoration Knarston Creek".

Coastal Protection:

Both Aquaparian Environmental Consulting Ltd. and Simpson Geotechnical Ltd. have been retained by the owners to prepare a shoreline protection and habitat restoration plan to support the proposed development.

The shorelines of the all the properties along this stretch of the foreshore have been armored; some with concrete retaining walls and others with rip. The existing shoreline of the subject parcel is in poor condition and constructed of old wood retaining wall with poorly placed armor rock in front that is located 1.5m to 2.0m beyond the surveyed property line.

Naturalizing the shoreline of the subject property presents a challenge (risk of erosion) due to the fact that both adjacent properties are hardened. In addition, storm frequency and energy are expected to increase due to climate change. Thus, a hybrid approach of hard and soft erosion control design has been recommended.

Simpson Geotechnical Ltd. has provided a plan for reconstruction of the shoreline slope and rock armouring to support a hybrid approach for the shore line treatment as shown on Attachment No. 5. Aquaparian has provided the vegetation plan required to achieve the habitat component of this approach. The intent is to prevent erosion of the shoreline while retaining some of the natural features a shoreline provides to the aquatic environment.

Flood Construction Level:

While the proposed new dwelling is 7.8 metres tall, it will need to be constructed to meet the flood construction level as defined by the Section 4.2.2(2) of the District of Lantzville Official Community Plan, which means an elevation 2.0 metres above the high water level of the Georgia Straight.

A variance from 8m to 9.8m is required as height is measured from the natural grade as per the definition within the District of Lantzville Zoning Bylaw No. 60, 2005.

PUBLIC CONSULTATION IMPLICATIONS

As the application does include a request to vary the Zoning Bylaw requirements for building height from 8m to 8.95m and to vary the setback from a watercourse from 15m to 10m, notifications were sent to the neighboring properties located within 60m of the subject property. The notification identifies the subject property and the purpose of the requested variance.

To date, we have received one letter expressing concern over the removal of a mature Douglas Fir used as a perch tree for eagles. It was explained to the concern citizen that there are currently no legislation to protect perch trees – only nesting trees are protected. In addition, the arborist report dated June 21, 2016 prepared by Branching Out Urban Forestry stated that the trees show signs internal decay and recommends removal of the trees as they present a potential hazard.

SUMMARY

The applicant is requesting Council to consider approving a development permit within the DPA I-Watercourse Protection and DPA IV- Coastal Protection Development Permit Area pursuant to the "District of Lantzville Official Community Plan Bylaw No. 50, 2005", and to grant variances for:

- i. The proposed building height from 8 m to 9.8m and
- ii. The watercourse setback from 15m to 10m

for the purpose of accommodating a proposed new dwelling.

Staff supports the proposed development permits with variances to the maximum building height and watercourse setback.

Staff have reviewed the reports and plans provided by both the Environmental and Geotechnical consultants and concur with the recommendations provided. It is recommended that Development Permit Application No. 3060-20-DP16-004 be approved, subject to the general requirements outlined in Schedule No. 1 attached.







Lot 1, District Lot 53, Nanoose District, Plan 22717




Site for Existing House






Attachment No. 3





Re: Water Supply Strategic Plan

I acknowledge receipt of your letter dated June 28, 2016 requesting a formal response within thirty (30) days to your request to amend the Water Agreement between the City of Nanaimo and the District of Lantzville dated September 8, 2014.

Recently, Snuneymuxw First Nation notified the City it wishes to engage on important issues such as water supply in accordance with an existing protocol between the parties and as part of our joint work on a framework for the planning and development of resources and lands within the City boundaries and SFN lands. This is not the first time that neighbouring communities have wished to engage the City on water supply.

The City will be updating the Water Supply Strategic Plan in 2016-2017. We believe it is critically important to run scenarios to understand the impacts of climate change, and where we see significant development throughout Nanaimo's boundaries and adjacent communities such as Lantzville and Snuneymuxw prior to making any decisions to amend the Water Agreement.

As you know, in 2004 the Greater Nanaimo Water District was dissolved, and this function was transferred authorities over the supply of water to the City of Nanaimo. The Act required City to adopt Bylaw No. 7088, A Bylaw to Establish Terms of Reference for the Water Supply Advisory Committee. The mandate of that committee is to garner opinions of the governing bodies of the users outside the jurisdiction of the City of Nanaimo on all issues related to the services and supply of the City of Nanaimo water supply that would impact those users outside the City.

Accordingly, we would like to invite the District to a meeting with the City, SFN and elected representatives from South West Extension in the near future to discuss our respective views on water and water supply. We believe this is a necessary step before we proceed with any decisions about amendments to our water agreement.

PURPOSE

To update Council on the results of the works carried out to date on the District's Wellfield.

BACKGROUND

At the regular Council meeting held on July 11, 2016, Council passed the following motion:

THAT Council directs staff to provide an update on the rehabilitation within the District's Harby Road Wellfield; AND FURTHER THAT staff contact the owners of Well #11 and invite them to include (at their cost) Well #11 during pump testing of the District's Harby Road Wellfield once the well rehab is complete.

DISCUSSION

On October 15, 2014, Lowen Hydrogeology Consulting Ltd. produced the Phase 1 of Stage 1 Wellfield Management Plan for the Harby Road Wellfield. The Plan provided several recommendations on how to increase the capacity of the wells within the Harby Road Wellfield. One of those recommendations was to carry out an estimation of the well efficiencies at the Harby Road Wellfield. On March 31, 2015 Lowen Hydrogeology Consulting Ltd. provided the District with the Harby Road Wellfield, Estimation of Well Efficiencies Report. From that report came the recommendation to replace Well #6 with a new well.

Staff have been working on the replacement of Well #6 and to date the following works have been carried out:

- A new well was drilled to a maximum depth of 24.68 meters;
- The well tested at 186 US gallons per minute (USgpm) (1,014 cubic meters per day (m³ pd)) over a 24-hour period;
- Piping design has been completed and forwarded to Island Health with an application for construction permit;
- The pump and piping for the well has been ordered;
- Quotes for the materials to finish the connection of the new well to the system are expected to be in soon.

As stated above, the new well (Well #6a), has a yield of 186 USgpm (1014 m³ pd). As a comparison, the original Well #6 produced only 100 USgpm (543 m³ pd); that provides an additional 86 USgpm (469 m³ pd). Staff are hoping to have Well #6a online by the end of August.

Another recommendation that came out of the March 31, 2015, Lowen Hydrogeology Consulting Ltd. Harby Road Wellfield, Estimation of Well Efficiencies Report was the rehabilitation of District Well #9.

Drillwell Enterprises Ltd. was hired to carry out works on the Well #9 rehabilitation. The works consisted of removing the pump and piping, placing a plunging tool within the Well and using the water within the Well to flush the screen vigorously. Prior to the works being done Well #9 was producing 35 USgpm (190 m³ pd). After works were complete, Well #9 is now producing 95 USgpm (518 m³ pd) exceeding its original design.

The final recommendations from the March 31, 2015, Lowen Hydrogeology Consulting Ltd. Harby Road Wellfield, Estimation of Well Efficiencies Report were regarding the rehabilitation of District Wells #4 and #12. Works on Wells #4 and #12 have not begun as Well #6a and Well #9 need to be connected and actively producing prior to taking Wells #4 and #12 offline.

Currently Well #4 is producing 142 USgpm (775 m³ pd) and Well #12 is producing 102 USgpm (556 m³ pd) and are expected to increase in capacity by 26% and 44% respectively, as per the 2015 Lowen Hydrogeology Consulting Ltd. Harby Road Wellfield, Estimation of Well Efficiencies Report.

Once Well #6a and Well #9 are connected and producing, the total water available to the District, prior to the rehabilitation of Wells #4 and #12, will be 525.2 USgpm (2,863 m³ pd).

It should be noted that the capacities for both Well #6a and Well #9 have been verified by a Professional Hydrogeologist. It is expected that once works are completed on all of the District Wells, the Wellfield capacity will then be re-evaluated with a 24-hour pump test of all wells simultaneously.

Currently, the District has 892 connections. Using the current standard per connection, the District requires 3,032.8 m³ pd to supply its current connections.

Staff has asked the owner of Well #11 if they wish to be included in the pump test at their own costs; the owner has indicated they would like to have Well #11 included into the testing once the Wellfield rehab is complete.

SUMMARY

As stated above, once Wells #6a and #9 are up and running, the amount of water available to the District, prior to the rehabilitation of Wells #12 and #4, is expected to be 2,863 m³ pd. The amount required by the current standards for the 892 connections is 3,032.8 m³ pd.

Once Wells #6a and #9 are back online, staff will begin works on Wells #4 and #12. The current capacity noted above has exceeded the expectations of the Wellfield Management Plan for the Harby Road Wellfield without the rehabilitation of Wells #4 and #12, therefore, retesting the capacity of the Wellfield once the rehabilitation works are complete is recommended.

Council has requested an update on the rehabilitation of the Harby Road Wellfield and staff requests that Council receive this report for information.

A BYLAW TO ENLARGE LANTZVILLE SANITARY SEWER COLLECTION SYSTEM – PHASE 2 LOCAL AREA SERVICE WITHIN THE DISTRICT OF LANTZVILLE FOR THE PURPOSE OF ESTABLISHING, CONSTRUCTING, OPERATING, MAINTAINING AND REPLACING A LOCAL SERVICE FOR THE COLLECTION, CONVEYANCE, TREATMENT AND DISPOSAL OF SEWAGE

WHEREAS Council established a local area service under the provisions of Section 211 of the *Community Charter* known as "District of Lantzville Sanitary Sewer Collection System – Phase 2";

AND WHEREAS the Council of the District of Lantzville may, by bylaw, enlarge a local service area under the provisions of Section 218 of the *Community Charter*;

AND WHEREAS Section 211 of the *Community Charter*, states that the requirements under section 211 (1) (requirements for establishing a local area service) apply only in relation to the area to be included or excluded from the local service area and not to the rest of the local service area;

AND WHEREAS Council has been petitioned to enlarge the Lantzville Sanitary Sewer Collection System – Phase 2 Local Area Service to include 7468 Lantzville Road;

AND WHEREAS the Corporate Officer has certified that the petition received for the works does constitute a sufficient petition signed by a majority of the owners, representing at least half of the value of the parcels that are liable to be specially charged;

AND WHEREAS it is deemed expedient to grant the request of the petitioners in the manner hereinafter provided and proceed with the works;

NOW THEREFORE BE IT RESOLVED that the Council of the District of Lantzville in open meeting assembled, enacts as follows:



PURPOSE

To provide Council District of Lantzville Water Asset Replacement Reserve Fund Transferring Bylaw No. 129, 2016 for consideration of first three readings.

BACKGROUND

The District currently holds two capital reserves relating to water assets: Waterworks Replacement Reserve Fund and Water Asset Replacement Reserve Fund.

DISCUSSION

The District established the Waterworks Replacement Reserve Fund in 2003 through the adoption of "Waterworks Replacement Reserve Fund Bylaw No. 2003-7." The bylaw stipulates that money set aside, and interest earned on it, may only be used for purchase of property, development, expansion, upgrading, replacement or renewal of water system assets.

The District also holds a Water Asset Replacement Reserve Fund. The District has no record of a bylaw establishing this reserve fund. It is believed that the reserve fund was established by the old Lantzville Improvement District and transferred to the District upon incorporation. An establishment bylaw in the Lantzville Improvement District records could not be located. The reserve establishment bylaws stipulate specifically what the funds can be used for. Section 189 (1) of the *Community* Charter states that "Subject to this section, money in a reserve fund, and interest earned on it, must be used only for the purpose for which the fund was established." Without the establishment bylaw, the funds cannot be expended.

The legislation does allow for one reserve fund to be transferred to another reserve fund if the function of the first reserve fund is fulfilled by the second reserve fund. It is believed that the intention and function of the Water Asset Replacement Reserve Fund is to utilize the funds for the purchase of water capital assets. This function is captured in the District's Waterworks Replacement Reserve Fund. Transferring of the funds in the Water Asset Replacement Reserve Fund to the Waterworks Replacement Reserve Fund would facilitate for the expenditure of the funds currently held in the Water Asset Replacement Reserve Fund.

As at July 25, 2016 the Waterworks Replacement Reserve Fund contained a balance of \$874,932 and the Water Asset Replacement Reserve Fund contained a balance of \$137,543. Both figures exclude interest earned in 2016.

FINANCIAL IMPLICATIONS

The Water Asset Replacement Reserve Fund currently contains a balance of \$137,543, excluding 2016 interest. Transferring this balance to the Waterworks Replacement Reserve Fund would facilitate the expenditure of these funds. Under the *Community Charter* the funds cannot currently be expended as the reserve establishment bylaw cannot be located.

COMMUNICATION STRATEGY

This report will be available for review by the public in the July 25, 2016 Council meeting agenda package and available on the District of Lantzville website.

STRATEGIC PLAN ALIGNMENT

This report is in line with the 2015-2018 Strategic Priorities Chart: Finance System Review

SUMMARY

The District currently has funds in the Water Asset Replacement Reserve Fund. An establishment bylaw for this reserve fund cannot be located, and without said bylaw, the funds cannot be expended per the

Community Charter. District of Lantzville Water Asset Replacement Reserve Fund Transferring Bylaw No. 129, 2016 will transfer the funds to the District's Waterworks Replacement Reserve Fund, which has the same function as the Water Asset Replacement Reserve Fund. This will allow the District to expend the funds currently held in the Water Asset Replacement Reserve Fund.

DISTRICT OF LANTZVILLE BYLAW NO. 129, 2016

A BYLAW AUTHORIZING THE DISTRICT OF LANTZVILLE TO TRANSFER THE WATER ASSET REPLACEMENT RESERVE FUND TO THE WATERWORKS REPLACEMENT RESERVE FUND

WHEREAS the District of Lantzville considers the function of the Water Asset Replacement Reserve Fund to be the same as that as the Waterworks Replacement Reserve Fund; and,

WHEREAS Section 189 (4) of the *Community Charter* authorizes Council to permanently transfer all or part of the amount of a reserve fund established for a capital purpose to another reserve fund establish for a capital purpose; and,

WHEREAS the District of Lantzville will transfer the funds from the Water Asset Replacement Reserve Fund, which it considers to be a reserve fund established for a capital purpose into the Waterworks Replacement Reserve Fund, which it also considers to be a reserve fund established for a capital purpose;

THEREFORE the Council of the District of Lantzville in open meeting assembled, enacts as follows:

- 1. Funds in the Water Asset Replacement Reserve Fund, in the amount of \$137,542.87 at July 25, 2016, plus any interest owing, will be permanently transferred to the Waterworks Replacement Reserve Fund.
- 2. This Bylaw may be cited for all purposes as "District of Lantzville Water Asset Replacement Reserve Fund Transferring Bylaw No. 129, 2016"

SUBJECT: Minetown Day 2016 Budget and Parade Road Closure September 10, 2016

RECOMMENDATION

THAT Council authorizes the closure to traffic of that portion of Lantzville Road from the intersection at Ware Road and Lantzville Road to Huddlestone Road, from 9:45 am to 11:00 am on Saturday, September 10, 2016 to facilitate the Minetown Day parade.

THAT Council instructs staff to increase the budget for Minetown Day 2016 from \$10,000 to \$13,000 to be funded by donation revenue; AND FURTHER THAT Council directs staff to prepare a Financial Plan amendment reflecting this change.

ALTERNATIVES

- THAT Council not authorize any road closures on Saturday, September 10, 2016, to facilitate the Minetown Day parade. Impact: No parade.
 - **THAT** Council not authorize a budget increase for Minetown Day 2016 to reflect expenditure of up to \$3,000 in donations. Impact: Event expenses would need to be reduced to within the \$10,000 budget in the Financial Plan.
- THAT Council authorizes a different route and road closures on Saturday, September 10, 2016, to facilitate the Minetown Day parade.
- 3. Other action as directed by Council.

ATTACHMENT(S)

PURPOSE

To obtain Council's authorization for the closure of a portion of Lantzville Road for the parade, and authorization for additional expenditure of Minetown Day in the amount of donations received annually (estimated at \$3,000) for the Minetown Day to be held on Saturday, September 10, 2016.

BACKGROUND

The *Motor Vehicle Act* and the *Community Charter* authorize Council, by bylaw, to regulate traffic on highways, including access to and from highways. In October, 2004, Council adopted District of Lantzville Traffic and Parking Regulations Bylaw No. 28, 2004, which includes a definition of 'Parade', authorizes the Bylaw Enforcement Officer (BEO) to place temporary 'no parking' signs or other traffic control devices along the route of any Parade (except on Arterial Highways), authorizes the BEO to temporarily close a highway or restrict or divert traffic if it is unsafe or unsuitable for traffic, and prohibits unauthorized persons from travelling upon a highway that is temporarily closed. Bylaw No. 28 includes specified officials and employees of the District in the definition of Bylaw Enforcement Officer for the purpose of that Bylaw, e.g. CAO, Corporate Administrator, Superintendent of Public Works.

Minetown Day has been an annual District event in Lantzville for many years, delivered through the Parks and Recreation Commission and community volunteers, with assistance from District staff. The purpose of Minetown Day is to celebrate Lantzville's coal mining heritage and to bring the community together for a day of family fun in an outdoor, fair-like setting. The activities include a parade. As the road closure for the parade is a planned event, the practice has been to have Council authorize the road closure.

The District of Lantzville Parks & Recreation Commission Bylaw states that the Commission is responsible for organizing, budgeting and conducting the annual Minetown Day event, including: fund raising, booking appropriate venues, scheduling activities, promoting, as well as seeking community volunteers and sponsorship. It goes on to provide that all revenues and expenditures be accounted in the District's financial records, monies received deposited in the District's general revenue account, and expenditures to be provided for in the Financial Plan, and authorized by the Director of Financial Services. In prior years, donations received have been expended for Minetown Day, in addition to the \$10,000 in the Financial Plan.

DISCUSSION

A road closure for the parade route will be required during the approximately one ¼ hour period that the parade is marshalling, taking place and disbanding (9:45 am – 11:00 am). The Parade Marshall this year (Councillor Mark Swain) and the Director of Public Works report that participants will marshall along Jack's Road and along Caillet Road, with the parade starting on Lantzville Road north of Ware Road, travel north on Lantzville Road, turn right on Huddlestone Road, and disband at Huddlestone Park. A road closure is not required for the marshalling area. The road closure for the parade route does allow for emergency vehicle access; however, vehicular traffic will be restricted to local traffic only during the time outlined in the recommendation. In consideration of training, liability and insurance requirements, a traffic control service has been contracted to provide traffic control during the event. The RCMP traffic section motorcycle detail will again be invited to participate; however, attendance is always subject to policing demands at the time.

As some of the donations for Minetown Day are known at this time, the Director of Financial Services recommends Council authorizing the expenditure of donation revenue (with the District expending the budgeted amount plus the donations received as in the past) and instructing staff to include the funds (revenue and expenditure) in the next housekeeping amendment of the Financial Plan. Expenditures exceeding the budget total of \$10,000, will only be authorized after and up to the amount of donations received to a total maximum of \$13,000. Currently, only \$10,000 is included in the Financial Plan and authorized as the available budget to spend on Minetown Day.

FINANCIAL IMPLICATIONS

Parade financial implications include staff time to prepare, publish and deliver road closure notices as in prior years (funded through the District's Operating Budget) and, new for 2016, traffic control services (estimated at \$400 to be funded through the District's Minetown Day Budget).

COMMUNICATION STRATEGY

If the temporary road closure is approved by Council, staff will, as in the past, hand-deliver letters to affected residents and businesses along the route advising of the road closure. Staff will also notify the District of Lantzville Fire Rescue Department, BC Ambulance, RCMP and Regional District of Nanaimo's Transit Services of the road closure. A notice advising of the road closure will also be placed in the August and September issues of the Community Update as well as on the District's website, bulletin board and through social media.

STRATEGIC PLAN ALIGNMENT

None.

SUMMARY

Members of the Parks and Recreation Commission along with numerous volunteers have planned the Minetown Day festivities, which will be held on Saturday, September 10, 2015 in Huddlestone Park beginning with a parade to the Park. To meet our obligations regarding authorization of the road closure to facilitate the parade, and to promote the event, staff recommend that Council pass the motion recommended in this report. To ensure expenditures are authorized in accordance with District bylaws, staff recommend Council authorizing the expenditure of donations received to a maximum of \$3,000 and instruct staff to include these funds in a housekeeping Financial Plan Bylaw amendment:

THAT Council authorizes the closure to traffic of that portion of Lantzville Road from the intersection at Ware Road and Lantzville Road to Huddlestone Road, from 9:45 am to 11:00 am on Saturday, September 10, 2016 to facilitate the Minetown Day parade.

THAT Council instructs staff to increase the budget for Minetown Day 2016 from \$10,000 to \$13,000 to be funded by donation revenue; AND FURTHER THAT Council directs staff to prepare a Financial Plan amendment reflecting this change.



PURPOSE

The purpose of this report is to provide Council with a brief reasoning as to why E-1 (1956 Chevrolet) should be sold to the Lantzville Volunteer Firefighters Association.

DISCUSSION

The current Fire Chief has been working through both inventories of assets, as well as creating efficiencies within the Fire Department. E-1 has been identified as an asset which is no longer in use for firefighting actions that could be disposed of. The Fire Chief has approached the Lantzville Volunteer Firefighters Association about the possibility of accepting the apparatus for the sum of \$1.00. As the Association has put in countless hours restoring and maintain the apparatus, they were supportive in receiving this potential offer (Attachment #1).

FINANCIAL IMPLICATIONS

By releasing the apparatus to the Association, the District will save on insurance and maintenance costs. Insurance wise, this will save the District \$567.00 yearly. Maintenance costs would be based on issues arising and are somewhat difficult to estimate.
